| Access to your school's<br>data | <ul> <li>Microsoft Teams or Google Classroom Platforms         If your school uses either of these systems to access our software and learning resources, then only your school has access to your data (access privileges are set up and manged by your school). Focus on Sound cannot view any school data in those systems.     </li> <li>Music First Application Cloud (MFAC UK)         If your school uses the MFAC UK system to access our software and learning resources, then your school has access to your data, as well as a very small number of employees from Focus on Sound Ltd and MusicFirst Ltd (MFAC UK), so we can manage your subscription and provide administration support where needed.     </li> </ul>   |

| Where your data is stored       | We store personal data on Amazon Web Services (AWS) encrypted servers in London, UK.   |
| How your data is kept<br>secure | <ul> <li>All personal data stored by us is held on encrypted servers in the UK</li> <li>Your school has full control over who has access to your data within your school</li> <li>Your school manages its passwords to our resources. Passwords are encrypted and only known by the user (except the initial password generated by us, which must then be changed by the user). The school is responsible for ensuring their employees and students understand how to keep their passwords safe.</li> <li>If your school uses the MFAC UK system and you want us to upload your data onto this system on your behalf, you will transfer this data securely to us using OneDrive, a secure file sharing platform which has end-to-end encryption in place. Once uploaded to the MFAC UK system, we immediately delete the data held in OneDrive.</li> <li>Only a very limited number of our employees or data processors have access to the data held within the MFAC UK system (max. 10 people). Access is restricted on a 'need to know' basis and only for service support or system maintenance purposes. These individuals are subject to confidentiality and are aware of their data protection and security responsibilities.</li> </ul> |



| Amending or deleting your data | The school<br>Your system administrators can amend or delete the data and users within your Google Classroom or<br>Microsoft Teams platform and within the MFAC UK system, at any time during your subscription. You<br>can also ask us to carry out these tasks on your behalf, should you require technical support.
